#### **I. Call to Order**

Chair Hammond called meeting to order at 3:02 PM and asked Kalie Snyder to conduct roll call and housekeeping items.

#### **II. Approval of May 11, 2023, Meeting Minutes**

#### **III. Internet for All Event: Connecting the Commonwealth of Pennsylvania**

Kalie Snyder provided details and overview of the event taking place at the Ramada Hotel and Convention Center in State College PA on July 13. The event is intended to be educational and information sharing for possible applicants, industry professionals and all entities interested in broadband expansion. Event hosts are the NTIA, the PBDA and other collaborators PML, PSATS, PBADS and CCAP

Lisa Davis asked what roll the NTIA will have. Kalie reiterated that they are hosting and assisting with identifying agenda topics and panelists. Lisa recommended a segment with a panelist who is looking to apply or will be assisting applicants. To which Kalie commented that we're looking at a best practices and a topic around that. Lisa also asked about technical assistance to which Kalie mentioned that Greg Alliger from the PBDA team will be providing technical assistance, that DCED Customer Service can assist with the logistics of the online portal to submit applications.

Mark Critz asked if applications will be submitted by the time of this event. Kalie confirmed that the program closes on July 10<sup>th</sup>. He also suggested a panel based on lessons learned from the CPF-BIP application process.
